We would refer to our letter reference NCH/BAM/CMP dated 06th July 2017 concerning the above subject.

We have updated the Construction Management Plan, as works on the project have progressed and we herewith enclose 6 no. copies of Submission 002 Rev 04 of the Construction Management Plan relating to the Main Contract Works – Phase A of the National Paediatric Hospital Development on St. James's Campus.

The changes to the previously submitted Construction Management Plan are shown as follows, with the original text in blue font and the new/amended text shown in yellow highlights:

- 2.4.2.1 – *This CMP covers the works to be constructed under Phase A of the Main Contract, with works to include piling, excavation, diversion of services and commencement of the structure up to lower ground floor level. Phase A will now include making safe in the medium term the existing building on the site of the proposed CIRC building on James Street. All works associated with making the building safe will be conducted in accordance with this document.*
- 2.4.2.1 – *Phase A has an anticipated start date of July 3rd 2017, and will continue for 15 months.* Phase A has an anticipated start date of July 3rd 2017, and will continue for 18 to 24 months and is dependent on the commencement of Phase B works.


